1. Bidders must submit the TAX compliance verification pin on a SARS letterhead. 2. In the case of the Joint venture, Tax compliance verification pins of all parties must be attached. 3. Certified Copy of Company Registration Certificate reflecting names and identity numbers of active shareholding must be attached (Except for sole traders and partnerships). 4. Copy of JV agreement (in case of JV) must be attached. 5. Municipal Rates & Taxes Clearance Certificate not older than 30 days or a lease agreement must be attached. 6. All supplementary / compulsory forms contained in the bid document must be completed and signed in full. 7. Failure to comply with the above-mentioned conditions may invalidate your bid. 8. Bidders must attach 3 year audited financial statements. 9. A bidder must submit a certificate signed by the bidder certifying that the bidder has no undisputed commitments for Municipal services towards a Municipality or other service provider in respect of which payment is overdue for more than 30 days. 10. Bidders must attach Certified or Original BBBEE Verification Certificate, in case of Joint Venture bidders must submit consolidated BBBEE Score card. 11. Bidders must be registered on the National Treasury Central Supplier Database and must submit their registration summary report.
